Sub : Filling up of the post of Superintendent on Deputation basis at Central Water and Power Research Station, Khadakwasla, Pune.

It is proposed to fill up four posts of Superintendent (Group B, Non-Gazetted, Ministerial) at CWPRS, Khadakwasla, Pune-24 (Government Organization under Ministry of Water Resources, River Development and Ganga Rejuvenation), **on deputation** basis in the scale of pay of PB-2 Rs.9300-34800 + Grade Pay Rs. 4200/- (Pre-revised) from **Officers of the Central Government** :

- (a) (i) holding analogous posts on regular basis in the parent cadre or department; **OR**
- (ii) with six years regular service in the Pay Band-1, Rs.5200-20200 with Grade Pay of Rs.2800 or equivalent in the parent cadre or department; **and**
- (b) Having six years experience in Administration, establishment and accounts matters.

**Note 1** : The Department Officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment by deputation and similarly the deputationists shall not be eligible for consideration for appointment by promotion.

**Note 2** : The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Government shall ordinarily not exceed three years.

**Note 3** : The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

**Note 4** : For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January 2006 (the date from which the revised pay structure based on Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post (s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

The selected officer will have option to draw their existing pay of the post held by them and deputation allowance or to opt for the pay fixation in the pay scale of the post of Superintendent, as per instructions contained in the DoPT's O.M. No.2/12/87-Estt., dated 20.04.1982.

It is requested that this may please be circulated widely amongst the department / attached, subordinate offices and applications in duplicate in the following proforma (Annexure-A) may be sent through proper channel to the office within 30 days from the date of issue of this circular / advertisement, along with supporting documents and completed & up-to date Character Roll (CR / APAR) for the last five years of the concerned employee and a certificate to this effect that there is no vigilance / disciplinary action is pending and the employee was not penalized for the last ten years may be attached. Officer who is volunteer for the post will not be permitted to withdrawal his name later. Applications received in the office directly or without up dated and completed CR/APAR or after the due date would not be considered and rejected.
